This is a great location with lots to do in the evening. The room rate is \$99.00 single or double per night. not get a room at our conference rate. It is suggested that you make your room reservation before September 20, and then cancel if necessary, but you will at least have a reservation. Each year we get many calls a few days before the conference from individuals who waited to make reservations until they received administrative approval, which sometimes only comes a few days before the conference, and they have to pay a much higher room rate or have to go to another hotel. The hotel will not charge your credit card until you actually check in.
